Lisette Aguilar is a senior director and Associate General Counsel at Sotheby's. During her 11 years at Sotheby's, Lisette has acted on cases such as Lancelot William Thwaytes v Sotheby's [2015] in which Sotheby's successfully defended a claim concerning the attribution and marketing of a copy of Caravaggio's "The Cardsharps", and Lord Coleridge v Sotheby's [2012] in which Sotheby's successfully defended a claim regarding the dating of a judicial collar of office. Lisette is one of two lawyers dealing with claims in Europe and Hong Kong involving attribution, authenticity, title, copyright and restitution issues and together they won the Legal 500 In-House Litigation Team of the Year Award 2015.
