Terms of Use for the Sotheby's Institute of Art – Online Learning Management System

Welcome to Sotheby's Institute of Art – Online, an academic content delivery service (the "Site"). The Site is owned and operated by Institute of Art – New York LLC (collectively, "us," or "we" or the "Institute"). By accessing or using our Site, you (or the "User") signify that you have read, understand, and agree to be bound by these Terms of Use ("Terms of Use"). If you do not agree to these Terms of Use, do not use the Site.

Eligibility

Use of the Site is void where prohibited. This Site is intended solely for users who have a high school diploma or the equivalent. Any registration by, use of, or access to the Site by anyone else is unauthorized, unlicensed and in violation of these Terms of Use. By using the Site, you represent and warrant that (a) you meet the above requirement; (b) you agree to abide by all of the terms and conditions of these Terms of Use; and (c) your use of the Site does not violate any applicable law or regulation.

Registration Data and Account Security
